

ORDINANCE 2013

- 001-2013 An ordinance of the Township of Hanover fixing the compensation for the office of Hanover Township Tax Collector effective January 1, 2014, pursuant to ACT 166 of 2012
- 002-2013 An ordinance of the Township of Hanover Amending the Hanover Township Traffic Code, *Ordinance No. 471*, establishing maximum vehicle weight restrictions on Oxford Street (10,000 pounds) and Lynwood Avenue (20,000 pounds) pursuant to the Township Engineer's January 4, 2013 Road Engineering Study and providing for posting and penalties for violations thereof.
- 003-2013 An ordinance of the Township of Hanover amending *Ordinance No. 023-2006* providing for inspection and issuance of occupancy permits of residential and non-residential structures within the Township of Hanover and providing for additional enforcement remedies.
- 004-2013 An ordinance of the Board of Commissioners of the Township of Hanover, Luzerne County, Pennsylvania, requiring all owners of improved property located within this Township and accessible to and whose principal building is within one hundred fifty feet from the sewer to make connection therewith; regulating the manner of making connections authorizing the township to make connections at the cost and expense of any owner of improved property failing to make such connection; adoption of additional rules and regulations; prohibiting the connection of privy vaults, cesspools, sinkholes, septic tanks and similar receptacles to any sewer and requiring abandonment thereof where a sewer is available, setting forth related matters and prescribing penalties for violation.
- 005-2013 An ordinance of the Township of Hanover vacating a public right of way, a fifteen (15') foot alley running one hundred (100')

feet through property now and formerly of Penn Refrigeration Service Corporation parallel and in between Woodbury Street and Dexter Street in the Township of Hanover.

- 006-2013 An ordinance of the Township of Hanover accepting and approving an intergovernmental sewer rental fee and cost-sharing agreement with Wilkes-Barre Township providing for proportionate sharing of costs for the use, maintenance and repair of the sanitary sewer line owned by and located in Hanover Township.
- 007-2013 An ordinance of the Township of Hanover accepting and approving an intergovernmental sewer rental fee and cost-sharing agreement with the Borough of Ashley providing for proportionate sharing of costs for the use, maintenance and repair of the sanitary sewer line owned by and located in Hanover Township.
- 009-2013 An ordinance of the Township of Hanover amending *Ordinance No. 003-2012* and imposing an annual user charge for non-residential establishments within the township based upon volume of discharge into the sanitary sewage collection and conveyance system of the Township of Hanover.
- 0110-2013 An ordinance of the Township of Hanover regulating residential rental properties and establishing landlord responsibility for nuisance violations and providing for additional enforcement remedies including closure of rental units.
- 011-2013 An ordinance of the Township of Hanover imposing a local service tax for year 2014 in the amount of Fifty Two (\$52.00) dollars on the privilege of engaging in occupation with the township pursuant to Act 7 of 2007 and Ordinance No. 005-2007, the Hanover Township Local Service Tax

- 012-2013 An ordinance of the Township of Hanover, County of Luzerne, Commonwealth of Pennsylvania, fixing the tax rate for the year 2014 at 5.5 Mills.
- 013-2013 An ordinance of the Township of Hanover, County of Luzerne, Commonwealth of Pennsylvania, imposing a realty transfer tax of one (1%) per centum for year 2014.
- 014-2013 An ordinance of the Township of Hanover, County of Luzerne, Commonwealth of Pennsylvania, imposing an earned income tax of one (1%) per centum.
- 015-2013 An ordinance of the Township of Hanover, County of Luzerne, Commonwealth of Pennsylvania, imposing a per capita tax of five (\$5.00) dollars
- 016-2013 An ordinance of the Township of Hanover, County of Luzerne, Commonwealth of Pennsylvania, imposing a mercantile and business privilege tax.
- 017-2013 An ordinance of the Township of Hanover, in the County of Luzerne, Commonwealth of Pennsylvania, appropriating specific sums estimated to be required for the specific purposes of the Municipal Government, hereinafter, set forth, during the year 2014.
- 018-2013 An ordinance of the Township of Hanover amending the Township's refuse and recycling *Ordinance No. 001-2012* providing for single stream refuse and recycling collection and related administrative provisions in the Township's refuse and recycling program.
